BIRTH: (\$15.00) Uncertified birth records for genealogy purposes are available to individuals who may not otherwise be entitled to receive a certified copy IF the person's date of birth precedes the current date by 75 years or more. A copy of a birth record of any deceased individual may be obtained by completing a special application form showing proof of the death. You may request this special application, **only for birth records after 1916. Form available at IDPH.Vitals@illinois.gov or by writing to:**

DEATH: (\$10.00) Uncertified genealogical copies of death records of persons who died more than 20 years ago, but not prior to 1916 may be requested from IDPH. The Illinois State Archives has microfilm copies of death records for deaths that occurred more than 50 years ago. Copies may be obtained IF the decedent was more than 25 years of age at the time of death.

Requests for searches of death records through the IDPH may be made for a fee of \$10.00 per name, if a record is found and is more than 20 years old, one uncertified copy would be issued without additional charge.

MARRIAGE: Illinois State Archives has a database of more than one million marriages for the years 1763 to 1900, copies may be obtained from Illinois Regional Area Depository system (cyberdriveillinois.com/departments/archives/irad/famtips.html). IDPH has a statewide index of marriages from 1962 through the current index date, for a \$5 fee it can verify the facts of a marriage or perform a search if you do not know the County where the marriage occurred.
