

EFFINGHAM COUNTY, ILLINOIS
STATEMENT OF TAX LEVIES

A resolution providing for and making of the annual tax levy for the fiscal period beginning the 1st day of December, 2020, and ending the 30th day of November, 2021, for the uses and purposes hereinafter set forth for the County of Effingham, in the State of Illinois.

WHEREIN, the County Board of Effingham County, Illinois, has determined that it is necessary to raise the sum of \$5,098,500.00 for the purpose set forth below.

NOW, THEREFORE BE IT RESOLVED, that there be and hereby is levied to be collected by general taxation, and the County Clerk is hereby directed to extend tax upon all the taxable property within said County of Effingham, in the State of Illinois, subject to taxation as the same is assessed and equalized for taxation for the State and County purposes for the fiscal period beginning the 1st day of December, 2020, and ending the 30th day of November, 2021, for the purpose of defraying the current expense for said period and payment of unfunded indebtedness for unpaid claims of said County at rates or amounts not to exceed maximum rates or amounts, whichever is lower, as specified below:
